

## WISE WOLVES CORPORATION LIMITED

### TERMS AND CONDITIONS

These Terms and Conditions ("Terms") are issued by Wise Wolves Corporation Limited ("WWCorp", "we," "our," or "us"), a private limited liability company incorporated under the laws of the Republic of Cyprus with registration no. HE 472767, having its registered office at 61, Spyrou Kyprianou, Mesa Geitonia, 4003, Limassol, Cyprus.

WWCorp consists of its group of companies and affiliated entities, including amongst others, of:

1. **Wise Wolves Capital (EU) Ltd**, a licensed administrative services provider regulated by the Cyprus Securities & Exchange Commission (CySEC) (license No. 186/196), with registration number HE 360935, having its registered address at 61, Spyrou Kyprianou, Mesa Geitonia, 4003, Limassol, Cyprus;
2. **Wise Wolves Finance Ltd**, a licensed Cyprus Investment Firm (CIF) regulated by CySEC (license No. 337/17), with registration number HE 361580, having its registered address at 61, Spyrou Kyprianou, Mesa Geitonia, 4003, Limassol, Cyprus;
3. **Wise Wolves Payment Institution Limited**, a licensed payment institution regulated by the Central Bank of Cyprus (license No. 115.1.2.32), with registration number HE 375477, having its registered address at 61, Spyrou Kyprianou, Mesa Geitonia, 4003, Limassol, Cyprus.
4. **Tria Bridge Ltd**, a licensed crypto-asset services provider (CASP register No. 013/2024) regulated by CySEC, with registration number HE 429492, having its registered address at 61, Spyrou Kyprianou, Mesa Geitonia, 4003, Limassol, Cyprus;
5. **Tria Software Limited**, a company incorporated under the laws of the Republic of Cyprus, with registration number HE 422111, having its registered address at 61, Spyrou Kyprianou, Mesa Geitonia, 4003, Limassol, Cyprus;
6. **Nobilis Consult DMCC**, a company incorporated under the laws of the Dubai Multi Commodities Centre Authority, with registration no. DMCC194487;
7. **Swiss Zeit Capital AG**, a company incorporated under the laws of Switzerland, with company number CHE-401.441.573, having its registered office is at c/o SMART Treuhand AG, Bösch 80A, 6331 Hünenberg, Switzerland;
8. **Wise Wolves USA Inc.** a company incorporated under the laws of the State of Delaware, having its registered office at 8 The Green, Ste A, Dover, DE 19901.

Together, these entities are referred to as the "Affiliated Entities".

## **1. Role of WWCorp**

WWCorp is a holding company. It does **not** provide financial, investment, payment, or other client-facing services. WWCorp's role is limited to holding shares in its subsidiaries. Any services are provided solely by the Affiliated Entities listed above, each operating under its own license and regulatory framework.

## **2. Disclaimer of Services**

Please note that, nothing on behalf of WWCorp shall be construed as, offering or providing investment advice, acting as a broker, dealer or financial intermediary, providing payment services, custody or portfolio management, engaging in any regulated activity under Cyprus or other applicable laws and regulations.

Any regulated services are the exclusive responsibility of the relevant Affiliated Entity. WWCorp assumes no responsibility or liability for such services.

## **3. Accuracy of Information**

WWCorp endeavours to ensure that corporate information it publishes is accurate. However, it provides no warranties or guarantees as to completeness, accuracy, or timeliness. Information about the services, products, or activities of Affiliated Entities is provided for reference only and may change without notice.

## **4. Privacy and Data Protection**

WWCorp does not provide services and collects no client data. The only personal data WWCorp may process is that voluntarily submitted via its website contact form (such as name, email address, and message). This information is used solely to respond to inquiries and is handled in accordance with our [Privacy Policy](#). Information is retained only as long as necessary to address the inquiry unless otherwise required by law.

WWCorp complies with the General Data Protection Regulation (EU) 2016/679 (GDPR). Users have rights to access, rectify, and erase personal data in accordance with GDPR. Personal data is retained only as long as necessary to fulfill the purpose of collection.

## **5. Fees**

WWCorp does not charge any fees to clients or third parties, as it does not itself provide services. Any fees associated with financial, investment, or payment services are charged directly by the relevant Affiliated Entities under separate agreements.

## **6. Intellectual Property**

All intellectual property rights in the WWCorp name, logos, and corporate materials remain the exclusive property of WWCorp. Intellectual property in platforms, technologies, or services provided by the Affiliated Entities remains with the respective entity. No license, right, or interest is granted by WWCorp in any intellectual property except as expressly stated.

Clients and counterparties must enter into separate agreements directly with the relevant licensed entity for any services received.

This Disclaimer constitutes the entire understanding with respect to WWCorp's role and replaces any prior statements inconsistent herewith. For clarity, service-related terms must be agreed separately with the relevant Affiliated Entity.

## **11. Governing Law**

These Terms and any non-contractual obligations arising from them are governed by and construed in accordance with the laws of the Republic of Cyprus. The courts of the Republic of Cyprus shall have exclusive jurisdiction over disputes.
